Rules

The races will be governed by The 2001-2004 ISAF Racing Rules of Sailing, the Prescriptions of the Canadian Sailing Association, the rules of the International Tasar Association (ITA) and any amendments made through the regatta Sailing Instructions.



Advertising

The category C requirements for advertising apply, competitors will be required to display the regatta sponsors advertising on the front 25% of their bow.

Eligibility

All Tasars that conform to the Rules of the ITA may enter, at least one crew member must be a member in good standing of a recognized Tasar Association.

Registration

Registration will be open Saturday June 22, 10 am to 11 am at the Fleming Bay launch site. Those entrants that wish to registrar early may do so by completing the attached registration form and sending it to Scott and Penny Davis. Entrants must submit a completed registration form with entry fee before 11 am June 22.
